BY CONSENT, THE TRIBUNAL ORDERS THAT:

PPCA Summons to MinterEllison

- A summons in the form annexed to these orders issue to MinterEllison.
- It will be sufficient answer to the summons for the documents required thereunder to be provided, on or before 4:00pm on 9 October 2023, by a secure electronic means, and subject to Orders 3 and 4 below, to the Respondent's external solicitors, Gilbert + Tobin, and the Applicant's external solicitors, Clayton Utz.
- 3 Subject to Order 4 below, the documents produced pursuant to the summons referred to in Orders 1 and 2 be treated as 'Restricted Access' and may only be made available to, and copied for use by, individuals who are entitled to access such documents pursuant to the Orders of the Tribunal dated 28 March 2023.
- 4 If a party wishes to contest or amend the confidentiality classification of any document produced pursuant to the summons referred to in Orders 1 and 2:

- (a) That party must first notify APRA AMCOS and the other party to this proceeding, and seek to agree on the amendment by negotiation.
- (b) If agreement cannot be reached, that party must provide a short written submission to the Tribunal relating to a variation of the classification, and serve that written submission on APRA AMCOS and the other party to this proceeding.
- (c) Any party opposing that variation of the classification, including APRA AMCOS or another third party maintaining that its confidential material is affected, will then have the opportunity to provide a short written submission in answer, which must be provided to the Tribunal and served on both parties to the proceedings within 10 days of receipt of the submission referred to in (b) above.
- (d) The matter will be determined by the Tribunal on the papers unless the Tribunal considers an oral hearing appropriate or any party or third party requests the opportunity to provide short oral submissions.
- Any reasonable costs reasonably incurred in complying with the summons pursuant to Orders 1 and 2 are to be shared equally by the Applicant and the Respondent, subject to any future application being made by either party to vary this order.
- In the event that the Applicant and/or Respondent contest the amount sought by MinterEllison in complying with the summons, the Registrar of the Tribunal or another person specified by the Tribunal, may hear and determine the reasonable costs payable pursuant to Order 5.

Other Summonses

- The question of whether to issue summonses or require production of documents sought by: (a) the Applicant from APRA AMCOS; (b) the Applicant from the Respondent; (c) the Respondent from the Applicant; and (d) the Respondent from television networks, be stood over until the next directions hearing.
- In relation to the disputed categories of documents sought by the Respondent from both the Applicant and television networks, Counsel for the parties are to confer at premises to be determined at 10:00am on 21 September 2023, and seek to reach agreement on those categories.

Arbitration means the arbitration between Australasian Performing Right Association Limited (**APRA**) and Free TV Australia Limited, the final award of which was handed down by Dr A Bennett AC SC (**Arbitrator**) on 25 March 2020

Document means any record of information and includes:
