**THE TRIBUNAL NOTES THAT:**

- A. By orders of the Tribunal made on 21 March 2024, the parties were to conduct survey pilots as described in Annexures A, B, C and D to those orders in accordance with the steps outlined in those Annexures.
- B. The parties have conducted the survey pilots described in Annexures A and B, which involve methodologies proposed by the Respondents.
- C. The parties are yet to conduct the survey pilots described in Annexures C and D, which involve methodologies proposed by the Applicant (**Applicant's Pilots**).
- D. Catholic Schools NSW Limited, a respondent to this proceeding, undertakes to the Applicant to use its reasonable endeavours to notify the Applicant by 12 September 2025 of:
  - (a) the names and addresses of the schools at which the Applicant may attempt to conduct the Applicant's Pilots (**Selected Schools**); and
  - (b) the date and time at which the Applicant may attempt to commence the Applicant's Pilots in the Selected Schools.

**THE TRIBUNAL ORDERS THAT:**

1. Any application by the Applicant for further orders in this proceeding is to be made on not less than 14 days' notice to the Respondents supported by, as appropriate, evidence and outline submissions.
2. The proceeding be listed for case management on 21 August 2026.
3. The Applicant is to notify the Tribunal promptly if the matter is resolved by the parties.
