THE TRIBUNAL ORDERS THAT:

1. By 18 March 2022, the Applicant provide to the Respondents:
 - (a) a copy of the Applicant's software application designed to capture data from Google Classroom (**DTE Application**), as referred to in the letter from the Applicant's solicitor dated 17 December 2021;
 - (b) any correspondence between the Applicant (or their agent) and both:
 - i. The Friendly Agency; and
 - ii. Inffrd,regarding the creation, delivery and operation of the DTE Application, including any supporting written materials for or in relation to the DTE Application provided to the Applicant by Inffrd or The Friendly Agency.
2. On or before 25 March 2022, the Applicant file and serve a Supplementary Position Paper in Reply which addresses:
 - (a) the Applicant's concerns with the Respondents' Solutions (as defined in the Respondents' Position Paper dated 12 October 2021); and
 - (b) the DTE Application.
3. By 1 April 2022, the Applicant give the Respondents a demonstration of the DTE Application, including to show the fields of data and or reports that may be generated by the application.

4. The matter be listed for a case management hearing on 2 May 2022 at 9:30 am.
