**THE TRIBUNAL ORDERS THAT:**

1. The parties be granted leave to inspect in the Registry any documents or articles produced by each of the following entities in answer to the summonses issued by the Tribunal on 21 March 2022:
  - a. Amazon.com Services LLC
  - b. Beamafilm Pty Limited
  - c. Foxtel Management Pty Limited
2. The parties be granted leave to inspect in the Registry any documents or articles produced by each of the following entities in answer to the summonses issued by the Tribunal on 13 May 2022:
  - a. German Society for Musical Performing and Mechanical Reproduction Rights (GEMA)
  - b. Irish Music Rights Organisation CLG (IMRO)
  - c. Society of Authors Composers and Publishers of Music (SACEM)

- d. Performing Right Society Ltd (PRS)
  - e. Society of Composers, Authors and Music Publishers of Canada (SOCAN)
  - f. CuriosityStream LLC
  - g. Universal Pictures Subscription Television Limited
  - h. RLJ Entertainment, Inc.
  - i. Composers and Authors Society of Hong Kong Ltd (CASH)
  - j. Finnish Composers' Copyright Society Teosto (TEOSTO)
  - k. Swedish Performing Rights Society (STIM)
  - l. OSA – Collective Rights Management Society for Musical Works (OSA)
3. If electronic uplifting of the documents or articles referred to in orders 1 and 2 above is possible, the parties be granted leave to electronically uplift those documents for the purposes of inspection and copying.
4. If electronic uplifting of the documents or articles referred to in orders 1 and 2 above is not possible, the parties be granted leave to uplift the physical documents or articles, for the purposes of inspection and copying, on the following conditions:
- a. Documents or articles not leave the custody of the solicitor, or counsel instructed by the solicitor.
  - b. Documents or articles be returned to the Registry in the same condition, order and packaging as when uplifted.
  - c. Documents or articles be returned promptly and, in any event, when an officer of the Registry so requests.
5. Until otherwise ordered, all documents referred to in orders 1 and 2 will be treated:
- a. subject to 5(c) below, in accordance with any classification they have been designated under the confidentiality regime ordered by the Tribunal on 4 August 2021; or
  - b. subject to 5(c) below, if a document has not been designated a particular classification, and unless the document has been produced expressly on the basis that it is not confidential, as Category A Confidential, until the entity who has

produced the document confirms any designation under the confidentiality regime ordered by the Tribunal on 4 August 2021; or

- c. notwithstanding 5(a) or 5(b) above, if a document referred to in order 2(a) to 2(e) and 2(i) to 2(l) has been designated as any classification other than Category A Confidential, as Category A Confidential under the confidentiality regime ordered by the Tribunal on 4 August 2021.
